- A copy of both your MDOT certification letter and photo ID as well as specify what you would like your business to be certified as (MBE, WBE, M/WBE).

If your application is approved, your certification is valid for two years. You can make changes to the information on file by submitting relevant supporting documents. Please be advised that changes should be made prior to your renewal date. Please review the Affidavit thoroughly before submitting it. Every item must be checked off on this document. Failure to do so will cause a delay in determining your eligibility for certification.
